### **2 MINUTES OF MEETING:**

The minutes of the meeting held on the Monday, 14 February 2011, having been circulated with the agenda were agreed and signed.

**3 DECLARATION OF INTEREST:** County Councillor Awford – flood forum.

### **4 PRESENTATION FROM ANTHONY PERRY ON THE CONSULTATION PAPER “MANAGING FLOOD RISK ON THE SEVERN ESTUARY”**

Anthony Perry introduced himself – he has been based at Tewkesbury for nearly 20 years. The plan has been produced to manage the tidal risk in the Severn Estuary over the next 100 years focussing on specific areas that are at greatest risk and within each of these they have considered a wide range of options. This is due to the UK climate changing and sea levels rising. In the longer term the EA is looking at protecting communities to a higher standard with defences strengthened as if nothing is done defences will be overwhelmed on a more regular basis. Factors that have to be considered are low lying land in the floodplain and what crops would be best to grow in these locations.

Parishioners asked various questions – why was the tip not shown on the map? The tip has been put in the wrong place – the water cannot leave Hempstead and Minsterworth is protecting Gloucester. One parishioner said that currently their insurance is £10,500 per annum but as from 2013 they won't be able to get any insurance when the agreement with the Government, called the Statement of Principles ends as currently this requires insurers to maintain cover on all properties with a risk of flood greater than once every 75 years.

Anthony Perry said that as from 2013 this will deter Developers from building on the floodplain as without insurance they will not be able to sell the houses.

Why is the Severn Estuary not dredged and the silt taken away – this used to be done on a regular basis? It was felt that dredging watercourses was beneficial but as the Estuary undergoes constant erosion it was decided to cease this operation.

Has the Severn Barrage been dropped? Yes the Government has scrapped this.

Are the EA actively objecting to any new development from Glos to Elmore? It is down to the District/Borough Councils to approve or refuse proposed planning applications even though the EA advises that it should be refused.
